Account Information

RESERVATIONS will be held for two (2) weeks while we wait for your *deposit cheque or e-transfer* and the *signed registration form* to arrive by e-mail, fax or mail.

A CONFIRMATION will be sent via email once your deposit has been received.

REFUNDS / CANCELLATION:

- If a camper must return home because of illness or accident, there will be a partial refund of fees.
- The deposit is not included in the refund after May 1st nor if illness or accident.
- No refund of the balance is made for late arrival, early departure or temporary withdrawals except reasons other than illness or accident.
- For CANCELLATION after May 1st, a refund may be had if it is due to illness or accident. The registration deposit is *NOT refundable* after May 1st, but \$350CAD may be used as a credit if registering in the following year. *If two cancellations were made but only one returns the following year, then only one deposit credit may be used.*
- **In the event that a child is dismissed from the camp by the directors for inappropriate behaviour, there will be no refund or reduction in fee**

DISHONOURD ITEMS (e.g. NSF cheques) will have a minimum charge of \$25.

CONNECTIONS DISCOUNT: We do very little advertising for the camp – word of mouth recommendation from satisfied *Wilvaken* families is our best publicity! As a concrete “Thank-you” for such referrals, we offer a *connections discount*. The plan is simple: for each *new* family that attends *Wilvaken* this year as a direct result of referral by a registered family, we give a \$100.00 +tx discount on camp fees to the *referring* family. For our new *Wilvaken* families, please make sure you name the referring family on the registration form! Connections discounts will be credited in the fall invoices.

PERSONAL EXTRAS is a deposit for personal expenses for *each child*. Against this deposit will be charged any particular individual expenses. This covers such items as tuck, camp photo, laundry, special outings or camping trips, water-skiing, flashlight, batteries, toothpaste, shampoo, prescription *Wilvaken* clothes etc. The deposit may not cover all expenses. Itemized statements for these personal expenses are sent at the end of the season, with a refund where applicable (or credit to your next year’s account). *Please do not send cash to camp with your child*, as it may get lost or go astray. We are not responsible for lost items or cash which is not in safekeeping in our office.

PICTURES AND FAMILY names may be used in our publicity. If you **do not wish** to have your child’s picture in our brochure or web site, or your name in our family list, please advise us in writing.

To HELP US CARE FOR YOUR CHILD, please **advise us on an attached note** if there is a recent change in marital status, family death, or any other such circumstance about which we should be aware. Explain adequately, and indicate who is the legal guardian of the child.

Payment and Fees

Registration must be accompanied by a **\$500 deposit dated today paid either by electronic transfer or cheque**. The balance will be paid by **May 1st** either by **electronic transfer or post-dated cheque** to cover the *expected* balance of your account. The deposit will be refunded, less a \$150 administration fee, if cancellation is requested before **May 1st**. Credit cards are not accepted. **Pay by:**

- **PREFERENCE - Interac (e-transfer) Email Money Transfer** directly from your bank account. If you have an email address and online banking password at a participating Canadian financial institution, you can send and receive money quickly and easily. Email carries the notice while the financial institutions securely transfer the money using existing payment networks.
- **Cheque payable to WILVAKEN INC.** or
- **Overseas** - please contact us for other payment options.

REGISTRATION AFTER **MAY 1st** must include full payment as your deposit, i.e. the **subtotal** column.

We will send a first invoice in May. Changes requested between time of registration and time of invoicing will be reflected on that invoice, as well as credit for the post-dated payment. A final invoice will be sent in the fall (after the summer rush!), to itemize personal extras, and incorporate any other changes effecting account charges or credits subsequent to our first invoicing. The following items should be included in calculating the post-dated payment:

THE ABOVE FEES DO NOT INCLUDE:

RIDING – A minimum of 6 lessons / 2 weeks (\$178+tax = **\$204.65**). Individual arrangements may be made for supplementary lessons, or even bringing your own horse to camp!

WATER-SKIING - **\$8.00** + tax per turn for those who are signed up. Charges will be made against the “personal extras” deposit on the fall invoice. *This amount is subject to revision based on gas prices during the camp season.*

CANOE TRIPS TO LA MAURICIE - **\$100** OR **HIKING TRIPS TO MONT MÉGANTIC** - **\$70** (to cover park fees and transportation) for those that take that option upon arrival at camp. This will be added to your final billing in the fall.

TRANSPORTATION: A chartered bus is offered from/to Montreal. \$80.00+ tax = **\$ 91.98 round trip** or \$47+tax = **\$ 54.04 one-way per person**.

AIRPORT TRIP: (P. E. TRUDEAU INTERNATIONAL AIRPORT) \$175+tax = **\$201.20 round trip** or \$98+tax = **\$112.68 one-way per person**.
